He stated expenses approximated \$6,000 from trophies, insurance, website and program printing. He stated that cash balance was approximately \$12,000. A motion was made by Fred Liberty and seconded by Doug Whiton to accept the report as presented. Passed U.

ATA Business:

The ATA's financial condition remains very solid despite the COVID related decline in revenue.

The AIM program continues to grow.

3S which provides cashiering software used at many of the larger shoots around the country is changing its fee structure.

They formerly licensed the software to organizations and cashiers on an annual basis. They now will be charging users a fee based on shooters attending each day. The fee is \$3 per day per shooter and will be difficult to absorb. No determination has been made as yet whether the software will be sued at the NH State Shoot.

Phil Wright was elected to the Accountable Plan Advisory Committee as the Eastern Zone representative and serves as its chairman.

AIM4NH REPORT

Missy Riley reported that the Barrels and Badges event will be held on April 9th at Cheshire Fish and Game. The AIM youth shooters are now NRA certified for gun safety. There are currently 11 participants in the AIM4NH program. Representatives from the AIM4NH program participated in a couple local sportsman's shows. Cheshire Fish and Game and 20th Skeet and Clays are currently hosting AIM4NH shooting. Major Waldron's is interested in organizing a youth team.

STATE TEAM

The State Team for 2022 was announced with 27 qualifying. Buckles and certificates will be awarded at the July meeting.
